2. Organizational changes

The following organizational changes will be undertaken in connection with the foundation of an affiliated company funded jointly with Olympus Corporation, which is scheduled for July 1, 2010, and the progress of management structural reforms.

(1) Concentration of service and solution businesses at the affiliated company

- The Business Development Division will be abolished and its functions will be transferred to Olympus Business Creation Corporation an affiliate of ITX Corporation.

(2) Abolition of Corporate Structural Reform Office and Planning Division

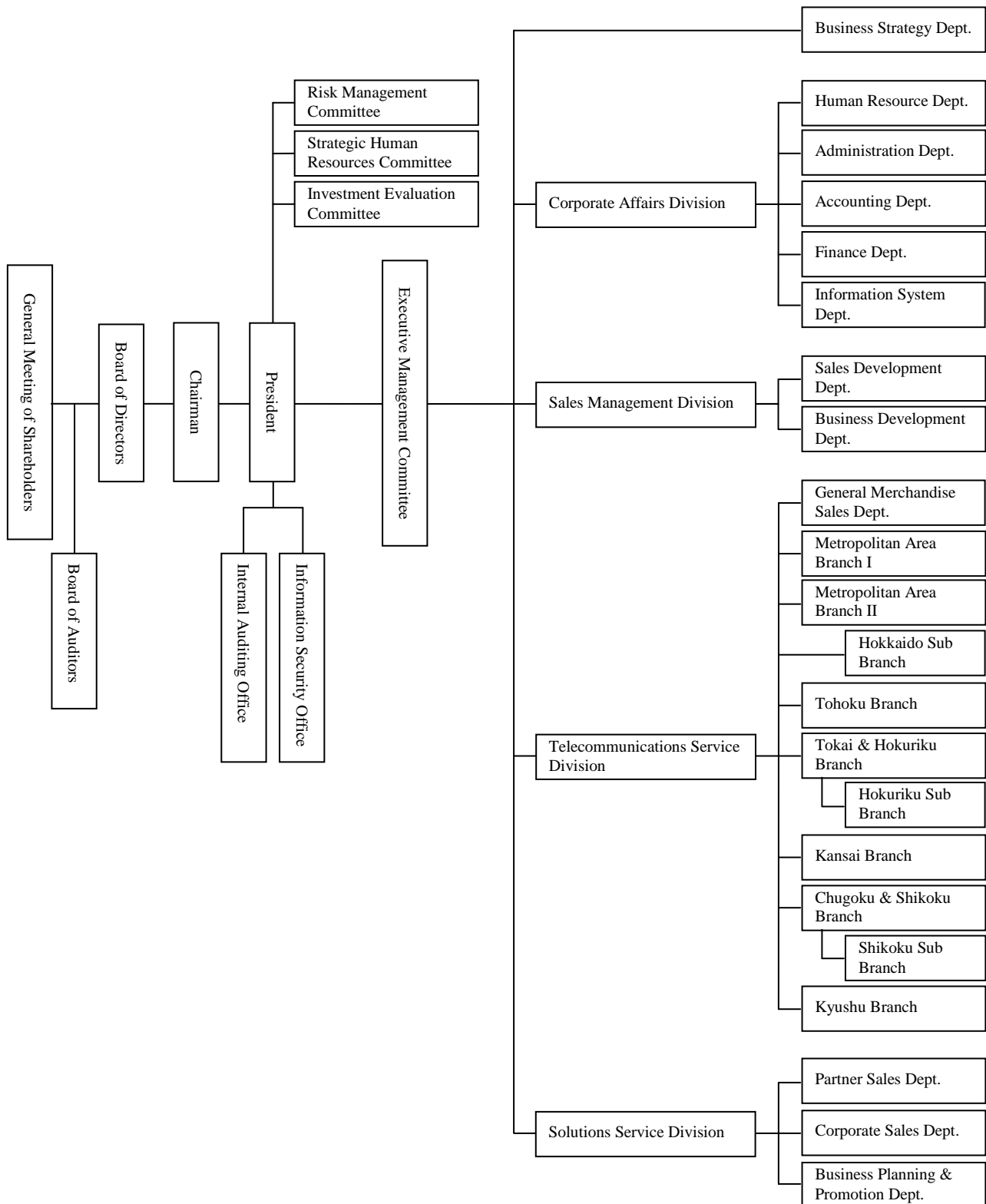
- The Corporate Structural Reform Office will be abolished as its initial purpose has been fulfilled with this restructuring.
- The functions of Business Management Department will be transferred to other divisions, the Business Strategy Department will report directly to the President, and Planning Division will be abolished.

(3) Further strengthening of bases for information and communication services

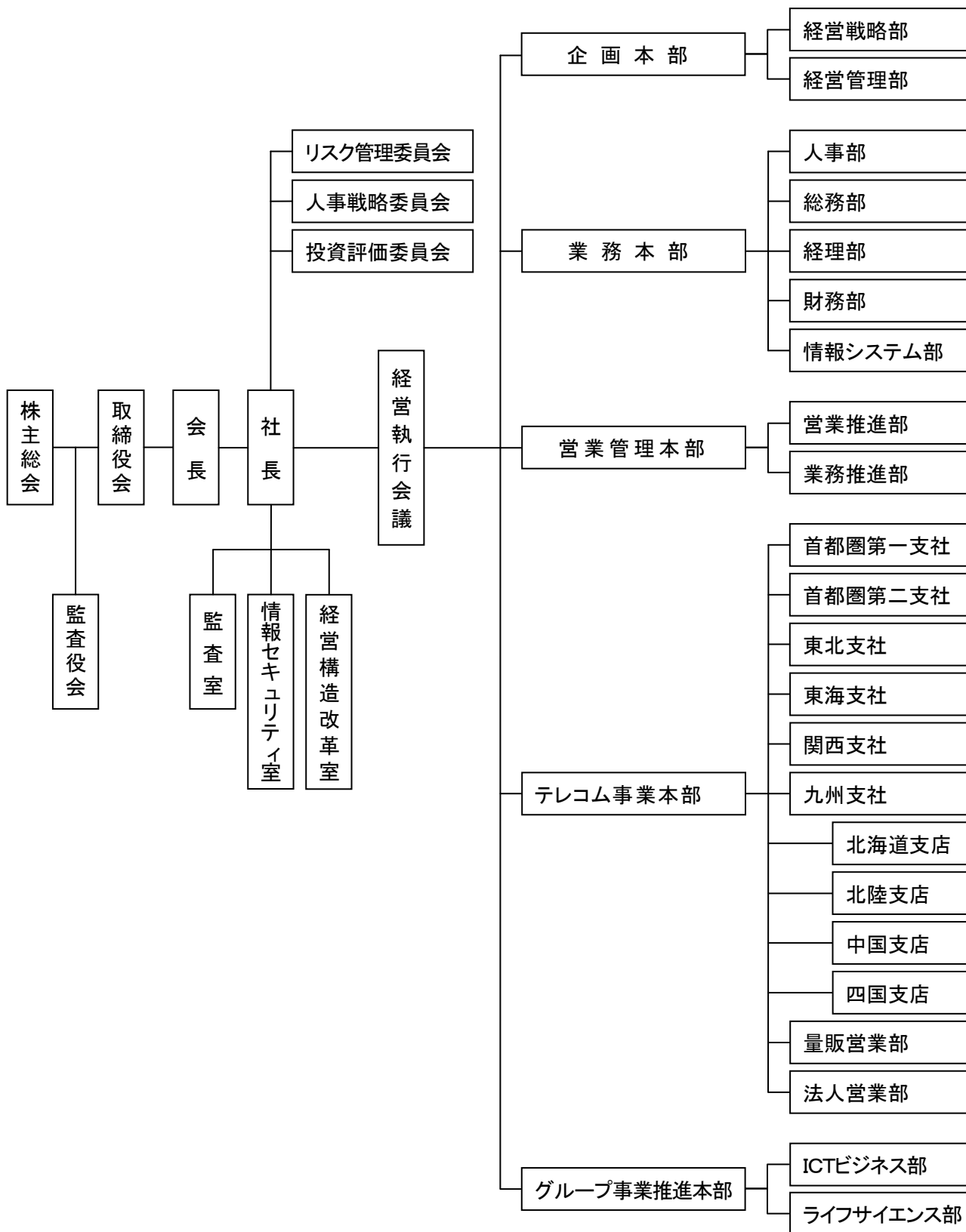
- The Solution Service Division will be established for the purpose of strengthening the corporate solution business, and Partner Sales Department, Corporate Sales Department, and Business Planning and Promotion Department will be placed under its control.
- For the purpose of strengthening the sales management function of the regional telecommunications service business, the functions of the Tokai and Hokuriku areas will be combined to establish Tokai and Hokuriku Branch, and Hokuriku Sub Branch will be placed under the control of Tokai and Hokuriku Branch.
- Likewise, the functions of the Chugoku and Shikoku areas will be combined to establish Chugoku and Shikoku Branch, and Shikoku Sub Branch will be placed under the control of Chugoku and Shikoku Branch.
